Performance Criteria: Cold Mix Materials for Patching and Pothole Repairs

Introduction and Background

Agrément South Africa (ASA) invites all Built Environment professionals who possess technical expertise in Cold Mix Materials for Patching and Pothole Repairs to comment on ASA's performance criteria document.

ASA was established in terms of a Ministerial Delegation of Authority by the Minister of Public Works and Infrastructure in 1969 to facilitate the introduction, application and utilisation of satisfactory innovation and technology development in the construction industry. ASA's vision is to be a centre of excellence for non-standardised construction products and systems. The entity's mission is to enhance its position as an internationally acknowledged South African centre of excellence, specialising in technical assessment, certification, quality assurance and R&D to ensure fitness-for-purpose of non-standardised construction related products and systems.

The Agrément Technical Agency carries out the evaluations on behalf of the Board of Agrément South Africa, which carries out its mandate by evaluating the fitness-for-purpose of construction industry innovations. The evaluations are based on various performance criteria and cover technical aspects of the material or building system such as structural strength and stability; durability; acoustic performance; thermal, condensation and energy performance, fire safety, water penetration etc. ASA criteria are approved by the Board, for use in the evaluation of performance and fitness-for-purpose of the subject products and systems undergoing the ASA certification process. Section 8.2.9 of the *Development of Agrément South Africa Assessment Criteria Procedure* makes provision for development of draft criteria which must undergo internal peer review prior to testing the draft criteria by soliciting public comments. The purpose of subjecting the draft criteria to a 60-day consultation period is to ensure that the criteria is appropriate for local conditions, and that it reflects South African norms and standards where applicable.



Scope of the Criteria

Cold Mix Materials for Patching and Pothole Repairs sets out criteria for the assessment of proprietary bituminous products with suitable properties to provide a waterproof and stable surfacing for patching or pothole repairs. The performance of a system under assessment is determined through laboratory tests, installation trials and based on prior performance. Performance is measured against parameters such as rut resistance, moisture resistance and long-term voids content.

Section 1 of the form deals with participant details and Section 2 deals with comments on the criteria. You may add more lines to Section 2 if required.
